II. CONTRACT/PURCHASE ORDER/BONDS

Contract Requirements between the Owner and Contractor will be a Standard AIA Form of Agreement Between Owner and Contractor where the basis of payment is a Stipulated Sum" with the unmodified "AIA Document A201™−2017, General Conditions of the Contract for Construction" adapted by reference.

For all contracts in excess of \$1,000,000.00, a 100% Performance and Payment Bond may be requested to be furnished by the owner. Please provide the cost of a Bond with your proposal.

If a bond is required, the proposed Bonding Company and Bond Form of the General Contractor must be acceptable by the Owner

III. FEMA PROVISIONS

The parties acknowledge their intent to fully comply with all FEMA requirements, including, without limitation, those contained on Exhibit "B" attached hereto and made a part hereof. To the extent the provisions of FEMA are inconsistent with any provisions of this Contract, the provisions of FEMA will control.

IV. BID PROPOSAL FORM

Each Bid Proposal shall be submitted on the Bid Proposal Form, which is included in this ITB, and be broken down according to the Bid Form. We request that the General Contractor attach a separate narrative to describe the scope of the work in detail. Please forward this scope of work narrative as soon as possible so that we may account for all scopes of work and ensure coverage of the same.

The Bid Proposal Form will not be considered a part of your Contract or Purchase Order Agreement nor will your written proposal.

V. EXECUTION CORRELATION & INTENT

Before submitting the Scope of Work Narrative & Bid Proposal, Bidders should carefully examine the Construction Documents, visit the site of work, fully inform yourself as to all existing conditions and limitations, and include in their Bid Proposal a sum sufficient to cover the cost of all items contemplated by the Construction Documents and as would be required to construct this facility for it's intended use.

The Bidder shall thoroughly examine all factors reasonably available to him, including, but not limited to the Drawings, soils report, site conditions, site history, local information, and seasonal weather conditions in the preparation of his bid. Soil report

data is not considered all conclusive; if the Bidder feels that further investigation of the site conditions are necessary they should inform Lemoine Disaster Recovery immediately.

Due to the anticipated schedule for this project, contractors will not be entitled to compensation for delays due to weather or changes in conditions due to weather and shall include the necessary cost in their estimates for the anticipated weather conditions.

The General Contractor is expected to thoroughly examine all factors reasonably available including examination of the site and Construction Documents, and make a request for any additional investigations, and decide the character of materials to be encountered, except for unusual "man made" conditions including, but not limited to, landfills, buried debris, abandoned sawmill residue and mine shafts.

The General Contractor is responsible for having a thorough knowledge of all the Construction documents, and all other information provided. Failure to acquaint himself with this information does not relieve him of the responsibility for providing totally inclusive pricing for his respective scope of work for the intended use of the facility.

In the case of an inconsistency between the Construction documents and other information provided, or within either document not clarified by Addendum, the better quality or greater quantity of work shall be provided. In the case of an inconsistency between the Documents, referenced standards, applicable codes and regulations not clarified by Addendum, the most stringent requirements or better quality or greater quantity of work shall be used in determining the Pricing.

VI. INTERPRETATIONS; DISCREPANCIES AND OMISSIONS

If Bidder is in doubt as the true meaning of any part of the Documents, all assumptions must be identified in your proposal.

VII. ADDENDA

All request for information and or clarifications to the project will be included in Addenda issued prior to the receipt of the Bid Proposals. Addenda will be issued to Lemoine Disaster Recovery by the Architect, and will then be forwarded to each of the participating bidders. An e-mail will be sent to all participating bidders to notify each party of the receipt of new information, such as Addenda.

VIII. ALTERNATES AND UNIT PRICES

Each Bidder must bid on all Alternates in the Bid Proposal that are applicable to his scope of work.

IX. SALES TAXES

General contractor quotes are required to include all applicable sales and/or use taxes on materials and equipment, which are affixed and made a part of the real estate of this project. Material supplier quotes are to exclude sales taxes. The Bidder shall include all other taxes required by law in this bid proposal.

X. SCHEDULE/WORKING HOURS

A construction schedule is also being requested on your bid form and will be factored in the selection of the General Contractor. The Diocese of Lake Charles goal for completion of this project is January 3^{rd} , 2021 Bidder is asked to provide estimated completion date if January 3^{rd} 2021 date is not deemed achievable.

Since time will be of the essence of this project, the General contractor should be prepared to furnish at all times sufficient, qualified and competent forces, manpower and supervision and adequate, conforming and usable materials, equipment, plant, tools and other necessary things, to achieve progress according to Program Managers progress schedule, including any special schedule for General Contractors Work and any revisions of such schedules by Contractor. Since the schedule is not all inclusive of every trade, please contact Lemoine in writing prior to bid should you or any of your suppliers be unsure of the time frame your work will take place. If you cannot meet the manpower requirements or the schedule, please do not bid the project. This project will work a minimum of 7 days per week or whatever is required to meet the most current construction schedule.

XI. INSURANCE REQUIREMENTS

Contractor shall obtain all insurance coverages scheduled below with limits and insurance carriers acceptable to the Contractor and file with the Owner before the commencement of work the required insurance coverages on ACORD Form Certificate of Liability Insurance. Nothing contained herein will be construed as an obligation of the Owner to review or accept or reject any certificate of insurance filed with the Owner by the Contractor.

Commercial General Liability Insurance

The policy will have the standard coverages of a Commercial General Liability Policy including: Premises and Operations coverage, independent Contractors coverage, Products and Completed Operations with no specific exclusions, Broad Form Property Damage coverage including Completed Operations and Explosion and Underground Property coverage.

Program Manager, Owner and their respective subsidiary or affiliated companies, agents, employees, and servants shall be named as Additional Insureds in accordance with the provisions above in this Article. Insurance coverages shall have a cross liability clause (severability of interest) and coverage shall be Primary and Non-Contributory as regards Additional Insureds, additionally the coverage will provide defense of the additional insureds after the Project has been put to its intended use.

Waiver of Subrogation in favor of Program Manager, Owner and their respective subsidiary or affiliated companies, agents, employees, and servants.

For a project involving roofing work, the Contractor's General Liability coverage must include a pollution liability coverage extension that affords coverage for claims resulting from jobsite fumes and vapors. In the event the roofing work is to be performed by a Contractor or their Subcontractors, the Owner requires the Contractor or its Subcontractors to provide a Certificate of Insurance for General Liability coverage with a pollution liability coverage extension that affords coverage for claims resulting from jobsite fumes and vapors. In such case, the Contractor shall have the Owner and the Owner's Lessor (if any) named as an additional insured and the Certificate of Insurance shall comply with the other requirements set forth.

SPECIAL CONDITIONS

ARTICLE 1 SAFETY

1. Purpose: Company-wide focus on safety which will require that everyone from the general contractor to its subcontractors, to employees, be more involved in safety on the project site.

2. Goals:

- 1. To maintain an accident and injury free environment.
- 2. Daily jobsite clean-up from the General Contactor and its subcontractors for a neat, clean, orderly professional job every day.
- 3. Jobsite safety meetings are mandatory to all contractors and workers.
- 4. Discipline Enforcement
- A. Safety violations will not be tolerated by the General Contractor and will be dealt with accordingly.

ARTICLE 2 QUALITY

- 1. The General Contractor & Subcontractors shall:
 - 1. Know the contract documents.
 - 2. Conduct & Attend pre-installation meetings.
 - Conduct follow-up inspections & correct deficiencies.
 - 4. Complete DOLC internal punch list.
 - 5. Only sell that which we would want to buy.

ARTICLE 3 LAYOUT

1. The General Contractor shall:

- 1. Establish property lines.
- 2. Provide datum bench for use of all subcontractors.
- 3. Establish building corner control points.

2. The General Contractor shall:

- 1. Protect building corner and property line control points.
- 2. Lay out excavation, paving, utilities and other improvements applicable to his work.
- 3. Lay out all work applicable to his work.
- 4. Lay out all other work required to complete his work except as noted to be performed by the General Contractor in this Article.

ARTICLE 4 FIELD OFFICES

- 1. The General Contractor shall:
 - 1. Provide field office and telephone for his use, the use of the owner and architects.
- 2. The General Contractor shall:
 - 1. Provide field office for his exclusive use as required.

ARTICLE 5 PROJECT SIGNS

No contractor signs shall be allowed except on equipment and trailers.

ARTICLE 6 TEMPORARY FENCE

The General Contractor shall provide and maintain temporary fencing around the site.

ARTICLE 7 TEMPORARY STORAGE

- 1. Temporary structures, sheds, trailers and material storage shall be arranged in a safe manner to avoid interfering with construction, public access or the Owner's operations. All locations of temporary structures, sheds, trailers and material storage shall be approved in advance by the General Contractor.
- 2. The General contractor shall relocate his temporary structures, sheds, trailers and materials in storage as often as required for construction progress as directed by the General Contractor.
- 3. Only limited storage space is available, and will be allocated by the Program Manager on a priority basis. Storage of materials outside the limits of construction but on the Owner's property is strictly prohibited without written permission from the Program Manager. You may not be able to get all your materials onsite at one time due to the site size and storage issues.

- 4. All cost relating to temporary storage and protection shall be borne by the General contractor requiring such storage and protection. The General Contractor shall retain full responsibility for any form of damage or deterioration to stored materials and any form of damage or deterioration caused by materials to surrounding surfaces.
- 5. Upon completion of the work, or sooner if directed by the Program Manager, the General Contractor shall remove his temporary structures and sheds and remove all debris and rubbish and place the area in a clean and orderly condition.

ARTICLE 8 HOISTING

General Contractor to provide all hoisting equipment necessary to complete the project.

ARTICLE 9 WATCHMAN

The services of a watchman will <u>not</u> be provided by either the Owner or the Program Manager.

ARTICLE 10 TEMPORARY TOILET FACILITIES

The General Contractor shall provide and maintain adequate chemical toilet facilities in a clean and sanitary condition for the use of it's Subcontractors/Labor Force.

ARTICLE 11 DRINKING WATER

The General Contractor shall provide his own drinking water.

ARTICLE 12 TEMPORARY WATER SUPPLY

The mechanical utilities contractor will be required to provide temporary water to the site within 15 days after construction starts.

ARTICLE 13 TEMPORARY ELECTRICAL POWER AND LIGHTING

The General contractor is to provide temporary power as needed throughout the project.

ARTICLE 14 ADJACENT STREETS

All General Contractor shall be responsible for the necessary cleaning and repairing of damage to adjacent streets resulting from his operations. General Contractor to be responsible for all necessary traffic control.

ARTICLE 15 PROTECTION OF EXISTING FACILITIES

- 1. The General Contractor shall provide and maintain proper shoring and bracing for existing underground utilities, sewers, and building foundations, encountered during his excavation work, to protect them from collapse or other type of damage until such time as they are to be removed, incorporated into the new work, or can be properly backfilled upon completion of new work.
 - 2. The General Contractor shall provide and maintain protection during sitework for all existing lawns, trees, curbs, gutters, drives, walks, and

buildings, not noted for removal. Damaged work shall be repaired or replaced, and damaged lawns shall be replaced with sod. Trees shall be protected until final grading has been completed.

ARTICLE 16 DISRUPTION OF EXISTING SERVICES

All work relating to the disruption of existing services shall be coordinated with the Owner and at such time as scheduled by the Program Manager.

ARTICLE 17 BANK PROTECTION

The General Contractor shall provide and maintain proper bank protection to prevent earth from caving or washing into the building excavation. Where adjacent property lines, structures, utilities, streets, driveways, or other site improvements do not allow the earth to be excavated to its natural angle of repose without risk of damage. The General contractor shall be responsible for all costs relating to any damages caused by settlements and/or displacements due to improper bank protection related to this General contractors Scope of Work.

ARTICLE 18 DEWATERING

General contractor shall maintain adequate drainage of disturbed areas during construction, including ditches, sumps and temporary pumps. Include all measures necessary for progress of all items of work under your Subcontract.

ARTICLE 19 ACCESS ROAD

The General Contractor shall provide and maintain an access road.

ARTICLE 20 ENVIRONMENTAL REQUIREMENTS

1. General contractor shall construct temporary erosion control systems as shown on the plans or as directed by the engineer to protect adjacent properties and water resources from erosion and sedimentation.

ARTICLE 21 CONSTRUCTION CHANGE DIRECTIVES

- 1. All quotations for changes, be they additions or deductions, shall be submitted in a complete itemized breakdown form acceptable to Architect/Engineer, using Contract Unit Prices when set forth therein. The value of any and all such additions or deductions shall be determined as set forth below:
- 2. The itemized breakdown shall show unit quantities and costs of all labor and materials. Submit all verifying data as necessary or required by Architect/Engineer to support claims, such as copies or original invoices, payrolls, etc. The burden of proof of cost rests upon the Contractor. Contractor agrees that owner or Owner's Representative shall have the right, at reasonable times, to inspect and audit the books and records of Contractor to verify the propriety and allowability of such costs.
- 3. Compute requests for changes, be they additions or deductions, as follows:

a. EXHIBIT B

ADDITIONAL TERMS AND CONDITIONS FOR COMPLIANCE WITH 2 C.F.R. PART 200, APPENDIX II

1. REMEDIES

The parties agree that the Owner reserves all rights and privileges under applicable laws and regulations with respect to this contract in the event of a breach of contract, including but not limited to the right to institute legal proceedings in a court of competent jurisdiction seeking monetary damages, court costs and litigation expenses, as applicable.

2. TERMINATION FOR CAUSE AND CONVENIENCE

The parties agree that the Owner reserves the right to terminate the contract immediately, with written notice to the Contractor, in the event of a breach or default of the Contractor, including but not limited to situations in which the Contractor fails, after a reasonable opportunity to cure, to: (1) meet schedules, deadlines, and/or delivery dates within the time specified in the procurement solicitation, contract, and/or a purchase order; (2) make any payments owed; or (3) otherwise perform in accordance with the contract and/or the procurement solicitation. The Owner also reserves the right to terminate the contract immediately, with written notice to the Contractor, for convenience, if the Owner believes that it is in the best interest of the Owner to do so. In the event of a termination for convenience of the Owner, the Contractor will be compensated only for work performed and goods provided by the Owner as of the termination date. The amount of compensation due the Contractor in the event of a termination for the convenience of the Owner shall be a reasonable amount, using as a guide factors such as the percentage of work or services performed by the Contractor and accepted by the Owner as of the date of termination, the contract price and any unit prices specified in the contract, as applicable.

3. EQUAL EMPLOYMENT OPPORTUNITY

During the performance of this contract, the contractor agrees as follows:

a The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. The contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, sexual orientation, gender identity, or national origin. Such action shall include, but not be limited to the following:

Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.

b. The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, sexual orientation, gender identity, or national origin.

- c. The contractor will not discharge or in any other manner discriminate against any employee or applicant for employment because such employee or applicant has inquired about, discussed, or disclosed the compensation of the employee or applicant or another employee or applicant. This provision shall not apply to instances in which an employee who has access to the compensation information of other employees or applicants as a part of such employee's essential job functions discloses the compensation of such other employees or applicants to individuals who do not otherwise have access to such information, unless such disclosure is in response to a formal complaint or charge, in furtherance of an investigation, proceeding, hearing, or action, including an investigation conducted by the employer, or is consistent with the contractor's legal duty to furnish information.
- d. The contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- e. The contractor will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- f. The contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- g. In the event of the contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part and the contractor may be declared ineligible for further Government contracts or federally assisted construction contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- h. The contractor will include the portion of the sentence immediately preceding paragraph (a) and the provisions of paragraphs (a) through (g) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance:

Provided, however, that in the event a contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the administering agency, the contractor may request the United States to enter into such litigation to protect the interests of the United States.

The applicant further agrees that it will be bound by the above equal opportunity clause with respect to its own employment practices when it participates in federally assisted construction work: *Provided*, That if the applicant so participating is a State or local government, the above equal opportunity clause is not applicable to any agency,

4. DAVIS-BACON ACT

The Owner shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (b) of this section.
- d. Subcontracts. The contractor or subcontractor shall insert in any subcontracts the clauses set forth in paragraphs (a) through (d) of this section and also a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. a. Clean Air Act
